1. ITEMS FOR CONSIDERATION

1.1 Case No. AR-23-35

20 Audubon Cswy., Lindsay Wright & David Larue., request approval for a new landscape plan which includes the removal of some existing plants and trees, some changes to hardscape and the addition of trees, shrubs, groundcovers, and low voltage landscape lighting. The driveway will consist of 4 ft. x 4 ft. shell beige square travertine stones in an ashlar pattern separated by 4-6 in. artificial grass strips between. Items to be removed include the following: two Foxtail palms and a portion of existing sidewalk located in the SW front corner of the lot, Citrus trees and an Olive tree with understory shrubs located within the west side yard, a citrus tree and portions of Green Island Ficus hedge within the rear yard, three Coconut palms within the east side yard and five palms and some Jasmine vines within the front and center yard. Newly proposed landscaping includes: a redesigned centered landscape island at the front driveway with a combination of small Sago palms surrounded by Green Island Ficus hedges and Lilly Turf. Each front corner of the parcel will be anchored by a single Mediool Date palm in landscape beds consisting of numerous plantings including Silver Buttonwood trees, Orange Bird of Paradise, Fakahatchee grasses, Clusia, and Green Island Ficus. The center driveway courtyard landscaped areas will maintain an existing Green Island Ficus hedge and Jasmine wall vines with the addition of Climbing Fig, Thatch Palms, Bougainvillea and Vibernium. The west side yard and into the rear yard will maintain existing Clusia hedges, portions of Green Island Ficus hedge and Christmas palms with the addition of Gumbo Limbo trees, Montgomery Palms in landscape beds at the NW and NE rear corners combined with grasses, Green Island Ficus, and Thatch palms. Exiting sod and synthetic turf will be removed and replaced within existing footprints. A new 6 ft. 9 in. high black decorative custom front courtyard entry gate designed to match railings and 4 ft. high black decorative custom powder coated aluminum gates are proposed for the east and west front/side yards and will be connected to existing fence.
